In this matter, legal heirs of deceased respondent No.23(b), 43, 45 and 46 are to be brought on record.

Under Order 22 Rule 10(A) CPC, a duty has been cast upon the pleader of the parties, who have died to inform the Court about the death of such party. Resultantly, it follows that all the details of deceased party would be in the knowledge and easy access of the concerned counsel. Learned counsel for the deceased respondents is directed to furnish complete details of legal heirs of deceased
