1. After some arguments Mr. Sanjay Sharawat, learned senior counsel appearing on behalf of petitioners submits that the SLP (C) 11756/2023 titled as *The National Council for Teachers Education vs. Association of NCTE Approved Colleges Trust* filed by NCTE in an earlier round of litigation emanating from a public notice requiring the institutes to submit PAR for the previous years is pending before Hon'ble Supreme Court.
