I.A. No.6534/2022 (u/O XXXIX Rules 1 & 2 of CPC) &

1. It is submitted that the captioned IA is coming up for hearing before the Hon'ble Court on 28.10.2022.
2. Perusal of record would show that two replies on behalf of the defendant to the captioned IA vide diary no.1062043/2022 and 1075778/2022 are on record.
3. Ld. Counsel for plaintiff submits that both the replies are same and he further submits that to avoid any confusion, reply filed vide diary no.1075778/2022 may be considered as reply to captioned IA.
