- (i) Name of the person in whose favour the e-TDR/e-STDR have been issued, the mode of the issuance and whether the same are alive in the bank records or not.
- (ii) Whether there is any lien or charge on the same and whether any loan and advance have been taken against the same.
- (iii) Whether the same are on auto-renewal mode.
- (iv) Whether any duplicate copy has been issued in respect of the same.

4. The registry is directed to annex the copies of the e-TDR/e-STDR, copy of the order dated 28.07.2026 and this order alongwith the court notice and also to mention in the court notice that the concerned Branch Head is at liberty to appear before this court on the next date of hearing through video conferencing by using the link of this court i.e. <https://dhcdja.webex.com/meet/dja.dhc.vc4> and to contact this office at 011-2337989 for any clarification.



5. Learned counsel for respondent also requested for time to file fresh security bond. Let the same be filed before the next date of hearing with advance copy to other side.
