Ld. Counsel for Decree Holder has stated that the case has been sent to this Court for appointment of Bailiff as per directions of the Hon'ble Court in order dated 30.01.2025 for execution of the judgment and decree dated 04.03.2024 qua possession of the suit property.

Ld. Counsel for JD has stated that he has already filed RFA (OS)(COMM) 14/2024 which is fixed for hearing on 26.03.2025 and he has also filed objections to the present execution petition on the ground of non-executability of the judgment and decree.
