It is stated by learned counsel for the plaintiff that inadvertently proper Memo of Parties has not been filed by the plaintiff. At request, the correct/proper Amended Memo of Parties be filed by the plaintiff within two weeks with copy to the opposite side.

The defendant no.1,2,4&5, who have joined the proceeding through VC, submit that they do not wish to file any Written Statement as the said defendants are supporting the case of the plaintiff. They further submit that they may be given three weeks' time to file "No Objection" in this regard. Let the same be filed within three weeks with copy to the opposite side.

As per record, defendant no.3&9 have been served on 18.01.2023. However, no Written Statement has been filed by the said defendants till date. There is no



appearance on behalf of said defendants today to explain in this regard. Needless to say, Written Statement, if any, filed by defendant no.3&9 shall be taken on record as per law.

Mr. Sumit Suri, husband of the defendant no.6, who joined the proceedings through VC, seeks sometime to file Written Statement. Let Written Statement alongwith Affidavit of Admission/Denial of documents be filed by the defendant no.6 within statutory period from the date of service of summons with copy to the opposite side. Replication, if any, alongwith Affidavit of Admission/Denial of documents be filed by the plaintiff within stipulated period as prescribed by law with copy to the opposite side.

At this stage, learned counsel for the defendant no.7&8 is present and submits that he will file his Vakalatnama on behalf of the defendant no.7&8, shortly. Let needful be done as stated.

It is stated by learned counsel for the plaintiff that he has supplied complete paper book to the defendant no.7&8 on Whatsapp number provided by them in the court on 27.01.2023. However, no Written Statement has been filed by the defendant no.7&8 till date. Learned counsel for the defendant no.7&8 seeks sometime to file the same. Needless to say, Written Statement, if any, filed by the defendant no.7&8 shall be taken on record as per law.

Learned counsel for the defendant no.10/Kotak Mahindra Bank is present and seeks sometime to file Status Report. At request, the same be filed within two weeks with copy to the opposite side.



No Written Statement has been filed by defendant no.11/HDFC Bank till date. There is no appearance on behalf of defendant no.11 today to explain in this regard. So, right of the defendant no.11 to file Written Statement is ordered to be closed.
