The plaintiff has no filed correct/proper Amended Memo of Parties till date. In the interest of justice, no adverse order is being passed today and the last and final opportunity is granted to the plaintiff to file the same within a week with copy to the opposite side.

Previously, the defendant no.1,2,4&5 have sought time to file “*No Objection*” in the captioned matter. However, the same has not been filed by the said defendants till date. No Written Statement has also been filed by defendant no.1,2,4&5. Even otherwise, none is present on behalf of said defendants today to explain in this regard. Needless to say that law shall take its own course in this regard.

The right of defendant no.3&9 to file Written Statement was ordered to be forfeited on the last date of



hearing.

It is stated by learned counsel for the plaintiff that counsel for the defendant no.6 has appeared on 28.03.2023 before the Hon'ble Court and, therefore, he has not filed Affidavit of Service of defendant no.6 as ordered vide order dated 23.03.2023. He submits that he will file the same within two weeks. Let needful be done as stated.

As per record, the defendant no.7&8 have not re-filed the Written Statement till date despite seeking time on 23.03.2023. The said defendants have also not filed Affidavit of Admission/Denial of the documents despite available opportunity on the last date of hearing i.e. 23.03.2023. Thus, despite having sufficient time, the defendant no.7&8 have not taken steps for removing objections and bring Written Statement on record which is stated to have been filed vide diary no.515081. So, the Written Statement stated to have been filed by the defendant no.7&8 shall not be considered and also the right of defendant no.7&8 to file Affidavit of Admission/Denial of the documents is ordered to be closed.

It is stated by learned counsel for the defendant no.10 that he has removed all the objections qua Status Report but still the same is not placed by the Registry and that one weeks' time may be granted to take requisite steps and bring the same on record. So, learned counsel for the defendant no.10 is directed to bring Status report on record positively within one week.

The right of the defendant no.11 to file Written Statement has already been ordered to be closed.
