As per office note, summons sent to the defendant no.1 to 7 by way of ordinary process received back served.

None appeared on behalf of the defendant no.7 since morning despite repeated calls.

Written statement and affidavit of admission/denial of the documents already stated to be filed by the defendant no.6. It is submitted by counsel for the plaintiffs that the plaintiffs have already received copies of the written statement filed by the defendant no.6 but they have not received copy of the affidavit of admission/denial of the documents. It is submitted by counsel for the defendant no.6 that



he will supply the same during the course of the day.

Defendant no.1 to 3 stated to be served on 11/12/2019 and the defendant no.4 to 7 stated to be served on 12/12/2019.

It is submitted by counsel for the defendant no.4 & 5 that the defendant no.4 & 5 have already filed written statement and affidavit of admission/denial of the documents vide diary no. 8802 & 8804 on 07/01/2020. However, the same have not come on record. Counsel for the defendant no.4 & 5 seeks time for taking appropriate steps in this regard. Copies already stated to be supplied.

It is submitted by counsel for the defendant no.1 to 3 & 7 that the aforesaid defendants will file written statement and affidavit of admission/denial of the documents within statutory period and they will also supply advance copy of the same to the opposite counsel. Plaintiffs are directed to file replication, if any, and affidavit of admission/denial of the documents within two weeks from the date of receiving the copies of the written statement and affidavit of admission/denial of the documents with direction to supply advance copy of the same to the opposite counsel.

Steps for service not taken by the plaintiffs.

Counsel for the defendant no.1 to 6 accept the notice of the aforesaid application and seeks time for filing reply. Heard. Request is allowed. Reply be filed within a week with direction to supply advance copy of the same to the opposite counsel.

Rejoinder, if any, be filed within a week thereafter with



direction to supply the advance copy of the same to the opposite counsel.

Issue fresh notice of the aforesaid application to the defendant no.7, by all modes, returnable for **13th February, 2020**. Steps for service be taken within a week.

At joint request, re-notify the matter for completion of pleadings qua the suit and application and admission/denial of the documents on **13th February, 2020**.
