It is stated that the Order dated 28.06.2024, passed by a co-ordinate Bench of this Court in CS(OS) 600/2019, decreeing the Suit while allowing the application under Order XII Rule 6 CPC, was taken up in appeal in RFA(OS) 55/2024. It is stated that the Division Bench of this Court *vide* Order dated 17.12.2025 has set aside the Order dated 28.06.2024. It is stated that the Order dated 17.12.2025, passed by the Division Bench of this Court in RFA(OS) 55/2024, has been challenged before the Apex Court in Special Leave to Appeal (C) 1767/2026 and the same is pending before the Apex Court.

2. Though there is no stay on further proceedings in the present Suit, however, since the decision of the Apex Court will have a bearing on the present proceedings, this Court is inclined to adjourn the matter to 12.01.2027 to await the decision of the Apex Court.
