CS(COMM) 644/2024 & I.A. 3102/2025 (condonation of delay)

1. The delay of ninety days in filing the written statement is condoned, subject to payment of costs of ₹10,000/- by the defendant to the plaintiff within one (1) week from today.
2. I.A. 3102/2025 is disposed of accordingly.
3. Replication be filed as per the prescribed statutory time limits.
4. List before the Joint Registrar for completion of pleadings and admission/denial of documents on 8th May, 2025.
5. List for the Court on 29th August, 2025.

6. The delay of ninety days in filing the written statement on behalf of the defendants no.4 to 6 was condoned by the Joint Registrar *vide* order dated 6th February, 2025, subject to payment of costs of ₹6,000/- by the defendants no.4 to 6 to the plaintiff within three weeks.
7. Counsel for the plaintiff submits that the aforesaid written statement was not taken on record since the aforementioned costs were not paid by the defendants no.4 to 6 within the prescribed time limit.
8. In the interest of justice, the written statement filed on behalf of the defendants no.4 to 6 is permitted to be taken on record, subject to the payment of costs of ₹10,000/- by the defendants no.4 to 6 to the plaintiff within one week from today.
