I.A. No. 19711/2022 (by D-5 u/O VII Rule 11 CPC)

1. Pleadings are already completed.
2. Ld. Counsel for defendant no.5 has submitted that the plaintiff has paid previous cost of Rs.2,000/- to the defendant no.5 in terms of order dated 16.01.2025.
3. It is submitted that captioned IA is coming up for hearing before the Hon'ble Court on 17.09.2025.

I.A. No. 19009/2022 (by D-5 u/O I Rule 10 CPC seeking his deletion)

4. The plaintiff has failed to remove the objections in filing of the reply to the captioned IA vide diary no. 2317948/2023 dated 09.04.2025 despite sufficient opportunities. Period of 30 days for removal of objection



has already lapsed. Thus, the right to file reply on behalf of plaintiff stand closed.

5. Ld. Counsel for defendant no.5 has submitted that the plaintiff has paid previous cost of Rs.2,000/- to the defendant no.5 in terms of order dated 16.01.2025.

6. Perusal of record shows that separate written statements and affidavits of admission/denial were already filed on behalf of defendants no.1 to 3, defendant no.4 as well as defendant no.5.
7. The plaintiff has failed to remove the objections in filing replication qua defendants no.1 to 3 filed vide diary no.2317930/2023 dt. 9.4.2025, replication qua defendant no.4 filed vide diary no.2498818 dated 9.4.2025 and replication qua defendant no.5 filed vide diary no.2464378 dated 8.4.2025, despite sufficient opportunities and the period of 30 days for removal of objections has already lapsed. Thus, the right of plaintiff to file the replication to written statement of defendants stand closed.
8. Pleadings are complete.
9. Let Joint Document Schedule including hard copy of the same be filed at least two weeks before the next date.
10. Both the parties shall file hard copies of their documents at least two weeks before the next date.
11. Re-notify the matter for admission/denial of documents and further proceedings on **4th December, 2025**.
