1. Learned counsel for defendant nos. 1 and 2 states that since there is a dispute on the transcript of the impugned video no.3, defendant nos. 1 and 2 pray that an expert be appointed to prepare the transcript of the impugned video no. 3 filed by the defendant no. 2 in a pen-drive before this Court.

1.1 He states that it would be appropriate if the expert uses the industrial software known as 'Adobe Premiere Pro 2024'. He states that the cost of Local Commission shall be borne by defendant no. 2.

2. Learned counsel for the Petitioner states that she has no objection to the appointment of an independent Local Commissioner ('LC') for this purpose.



3. Accordingly, Mr. Ravi Shankar Parashar, Sr. Judicial Assistant (Digitization), Employee Code No. 27098519, Mobile No. 9873429831 working with the IT Department, Delhi High Court is appointed as IT-Local Commissioner and Ms. Shambhavi Kala, Advocate, (Mobile No. 9818668876, Enrolment No. D/5871/2020, e-mail id-shambhavi1721@gmail.com) is appointed as Advocate-Local Commissioner to collaborate with the IT-Local Commissioner in the preparation of the report as per the Rules.
4. The IT-Local Commissioner shall prepare a transcript of impugned video no. 3 using the software known as 'Adobe Premiere Pro 2024'. The Advocate-Local Commissioner shall collaborate in preparation of the report and verifying the transcript. The IT-Local Commissioner and Advocate-Local Commissioner are directed to file the joint report on or before 16.10.2024 with an advance copy to the counsel for the parties.
5. The fee of the IT-Local Commissioner and Advocate-Local Commissioner is fixed at Rs. 50,000/- each. The fees shall be borne by defendant no. 2 and paid on or before 14.10.2024.
