1. The writ is listed pursuant to the orders of the Hon'ble Supreme Court dated 8th April, 2019, reviving the writ petition limited to Prayer (B) in the writ petition.
2. In the present writ petition, the petitioners had sought quashing of the impugned OM No.17/1/2013-vig dated 1st March 2013, and Prayer B in the W.P.(C) No. 2070 of 2013 was seeking restrain on the respondents, its officers, agents, employees etc. from giving effect to the impugned OM No.17/1/2013-vig dated 1st March, 2013 as also OM NO. 399/9/2010-AVD-III dated 1st February, 2013.
3. In the writ petition itself it was informed that OM NO. 17/1/2013-vig was withdrawn on 13th March, 2016.
4. Once the OM dated 1st March, 2013 has been withdrawn by the respondent itself, the necessary consequence thereof would be, the same cannot be given effect to.
5. Learned counsel for the petitioner further states that no action was taken pursuant to the OM dated 1st March, 2013 and thus regularising the actions pursuant to OM dated 1st March, 2013 would also not arise.
6. Learned counsel for the respondents states that that the matter



has to be argued by the learned Additional Solicitor General and prays for an adjournment.
