1. Issue notice of the captioned IA to the plaintiff through counsel for next date of hearing, who may file reply to the captioned IA within two weeks from the date of service of notice and rejoinder thereto be filed before next date of hearing.

2. It is submitted that matter and captioned IA are coming up for hearing before the Hon'ble Court on 01.05.2024.
3. As per office noting, summons have been served upon both the defendants.
4. Office noting further shows that written statement along-with affidavit of admission/denial of documents as well



as vakalatnama were filed by defendant no.1. However, an application for condonation of delay in filing written statement is pending for consideration.

5. Office noting also shows that documents with list of documents were filed on behalf of defendant no.1 vide diary no.567257/2024.
6. Office noting further indicates that reply to captioned IA was filed on behalf of defendant no.1. No rejoinder to the said reply has been filed by the plaintiff. Let the same be filed within four weeks.

8. Let the pleadings be completed as per law.
9. Re-notify the matter for completion of pleadings and further proceedings on **24th April, 2024.**

12. At request of Ld. Counsel for defendant no.1, re-notify the counter-claim for consideration on **24th April, 2024.**
