I.A. No. 6184/2024 (moved in counter-claim by counter-claimant/D-1 for stay) &

I.A. No. 6185/2024 (moved in counter-claim by counter-claimant/D-1 u/S 151 of CPC)

1. No reply to the captioned IAs has been filed on behalf of the plaintiff. Time sought.

I.A. No. 6308/2024 (moved in suit by defendants for rejection of plaint)

2. No reply to the captioned IA has been filed on behalf of the plaintiff. Time sought.

I.A. No. 5825/2024 (moved in suit by D-1 for condonation of delay of 18 days in filing WS)

3. Ld. Counsel for plaintiff submits that he does not wish to



file any reply to the captioned IA and has no objection if the same is allowed.

4. Heard. For the reasons stated in the application and in view of the above submissions, delay in filing written statement on behalf of defendant no.1 is condoned and the same be taken on record if complete in other respect.
5. The captioned IA stands disposed off accordingly.

9. No written statement, affidavit of admission/denial of documents and reply to the captioned IA has been filed on behalf of defendant no.2.

11. It is submitted that the matter and all IAs are coming up for hearing before the Hon'ble Court on 01.05.2024.
12. Let the matter and all IAs be placed before Hon'ble Court for further directions on the date already fixed i.e. **01st May, 2024.**

16. Let the counter-claim be placed before Hon'ble Court for further directions on the date already fixed i.e. **01st May, 2024.**
