1. Allowed, subject to all just exceptions.
2. Application stands disposed of.

3. By way of the present petition, the petitioner is seeking following prayers:

“...1. Summon the trial court record from the Hon'ble Court of Sh.Abhinay Singh, JMFC-01/North-West, Rohini Courts Dethi in Cr. Gase No. 544688/2016 having FIR No.187/2016, under 35 section 420/467/471/120B/34 IPC Police Station Sultanpuri , Delhi.

2. Summon the court record from record room of Session Courts, North West, Rohini Courts, Delhi of Criminal Revision No. 111/2025 titled as “Jai Prakash vs State” decided by the Hon'ble Court of Sh. Vikram, ASJ-II Spl Judge NDPS (N-VV) Rohini Courts Delhi decided on 26,04 2025.



3. Set aside the impugned order dated 25.04.2025 passed by the Hon'ble Court of Sh. Vikram, ASJ-IISpl Judge NDPS (NW) Rohini Gourts Delhi in Cnminal Revision No. 1171/2025 tiled as "Jai Prakash vs State" and direct the trial court to frame the charges against respondent no.2 being accused in the case FIR No.187/2016, under section 420/467/471/120B/34 IPC Police Station Sultanpuri, Delhi.

4. Direct the Ld. Trial Court to frame charges against respondent no.3 in the case FIR WNo.187/2016, under section 420/467/471/120B/34 IPC Police Station Sultanpun , Delhi..."

4. Issue notice. The learned APP accepts notice on behalf of the State.
5. Issue notice to respondent no. 2 and 3 through all permissible modes, including electronically on filing of process fee and through Investigating Officer (IO) concerned.
6. List on 04.12.2025.
7. In the meantime, let the Trial Court Record, in digitized form, be called for, at least two days prior to the next date of hearing.
8. The order be uploaded on the website forthwith.
