1. On 14.12.2023, this Court directed as under:

“22.1. Defendants No. 1 to 4 shall, during the pendency of the proceedings, takedown and block access to the following links:

which are available for viewing at their respective platform.



22.2. In the event the videos in question resurface on the platforms of Defendants No. 1 to 4, the Plaintiff shall be at liberty to supply the concerned URLs to the said Defendants, who shall take appropriate action to block/ takedown the same, in accordance with law. However, in case Defendants No. 1 to 4 come to the conclusion that the content is not identical to the videos which have been enjoined by this order, they shall inform the Plaintiff of the same, within a period of one week from the date of receipt of the request, whereafter Plaintiff shall be free to approach this Court for appropriate directions.”

2. Defendant Nos. 1, 2 and 3 state that they have already complied with the order dated 14.12.2023.
3. It is directed that defendant Nos. 1, 2 and 3 shall remain bound by the directions passed in the order dated 14.12.2023
4. In view of the order passed today, prayers as far as defendant Nos. 1, 2 and 3 stands satisfied.
5. In case, any videos are uploaded by other defendants on the platform of defendant Nos. 1, 2 and 3 and the plaintiff finds the same in violation of the order dated 14.12.2023, the plaintiff shall inform defendant Nos. 1, 2 and 3 and they shall take appropriate action in term of para 22.2 of the order dated 14.12.2023
6. In view of the above, defendant Nos. 1, 2 and 3 are deleted from the memo of parties. Let the fresh amended memo of parties be filed before the next date of hearing.
7. List on 20.05.2024 before Joint Registrar for completion of pleadings.
