1. The captioned application was filed by the Plaintiffs seeking direction to SHO P.S. Jyoti Nagar to file a status report regarding the original sale deed dated 13.11.2000, which as per affidavit of Defendant No. 1 has been deposited with the Investigating Officer (IO) of the said P.S in FIR No. 621/2021.

2. In compliance with the order dated 17.01.2025, the SHO Police Station (PS) Jyoti Nagar has filed a Status Report dated 20.03.2025 wherein at paragraph 5, the status report reads as under:
