1. The present application has been moved on behalf of the plaintiff stating that in order dated 05.03.2025, it has been wrongly recorded that Ld. Counsel for defendant no.1 has paid previous cost of Rs.5,000/- to the plaintiff. It is further submitted that in fact the cost of Rs.5,000/- imposed upon the defendant vide order dated 21.12.2024 had not been paid.
2. Ld. Counsel for plaintiff has submitted that cost was not paid on previous date on behalf of defendant, however, in last order dated 5.3.2025, it is mentioned that the cost has been paid.



3. Ld. Counsel for defendant submits that by the last date of hearing, no cost was paid and he has no objection if the appropriate direction is made in order dated 5.3.2025.
4. Heard. There appears to be some typographical mistake in the order dated 5.3.2025. Let para no.2 of order dated 5.3.2025 be read as follows: "*Ld. Counsel for defendant has not paid previous cost of Rs.5,000/- to the plaintiff.*" The order dated 5.3.2025 stands modified accordingly.
5. The captioned IA stands disposed off accordingly.
