8. Let reply be filed by the respondent, within a period of four weeks.

9. Rejoinder thereto, if any, be filed within a period of two weeks, thereafter.

Considering the submissions made by learned Senior Counsel appearing for the petitioner, it is directed that, in case, any proposal with regard to the subject matter of the present writ petition is submitted before the Standing Committee/Corporation of the MCD, the order dated 20th March, 2024, passed by this Court in *W.P.(C) 2709/2024*, titled as “*M/s Tim Delhi Airport Advertising Pvt. Ltd. Versus Municipal Corporation of Delhi*”, shall also be placed along with the said proposal.
