File has been placed before me in compliance of order dated 16.12.2025. Petitioner Ms. Shivani Modi has been granted permission to travel abroad by the Hon'ble Court subject to conditions contained in order dated 16.12.2025.

In compliance of order dated 16.12.2025 passed by the Hon'ble Court, petitioner has handed over across the board the affidavit-cum-undertaking whereby she has undertaken that she shall abide by the terms contained in the affidavit. She has mentioned the complete itinerary including her stay at various stations abroad, residential/hotel addresses and phone number details in compliance of the Court order. It is submitted that the phone number provided would be used by her during her stay abroad, which number will be kept operational at all times, subject to all exceptions, including the period she is on board



the aircraft.

Vide order dated 16.12.2025 the Hon'ble Court has directed that the sum of Rs. 50 Lakhs already deposited by the petitioner in this Court shall remain as security.

Today, as per report of the registry, the sum of Rs. 50 Lakhs is lying deposited with the registry.

Besides, the petitioner has also furnished a copy of the air tickets that she has purchased for her travel to Phuket, Thailand. The petitioner shall be travelling w.e.f. 26.12.2025 to 06.01.2026.

The petitioner has joined the proceedings through virtual mode. She has been duly identified by her counsel. Petitioner affirms that she has signed the undertaking filed before this Court, the details of travel, contact furnished in the Court are true and correct and has also undertaken to be bound by the terms of undertaking and to abide by all the conditions imposed by the Hon'ble Court for her travel abroad by order dated 16.12.2025.

Petitioner has also filed the proof of service of the undertaking with relevant documents to the respondents.

Petitioner is directed that she shall furnish an undertaking upon her return to India, she shall participate in any proceedings against her and that she shall bound down by any orders that may be passed by the competent Court/authorities, subject to any challenges thereof and also file a self-attested copy of her passport along with copy of her Visa in the Court on her return to India.

Considering that the conditions have been complied with by the petitioner, she may travel, as permitted by the Hon'ble Court vide order dated 16.12.2025.
