4 CPC for substitution of LR's of D-1/plaintiff in counter-
claim and taking amended memo of parties on record)**

1. The matter is taken up today on filing of captioned IA.
2. It is submitted that the matter is coming up for hearing before the undersigned on 26.08.2025 and before the Hon'ble Court on 15.09.2025.
3. Ld. Counsel appearing for LR's of plaintiff/defendant no.1 in counter-claim accepts notice of the captioned IA and submits that he does not wish to file any reply to the captioned IA and has no objection if the same is allowed. He seeks some more time to file fresh vakalatnama on behalf of LR's of plaintiff/defendant no.1. Let the same be filed before next date of hearing.



4. Ld. Counsel for counter-claimant/defendant no.1 submits that plaintiff, who is defendant no.1 in counter-claim, has passed away on 21.02.2025 and he has been succeeded by his wife namely Mrs. Rajni Rawal and two daughters namely Ms. Malvika Rawal and Ms. Madhulika Rawal. He has further submitted that said LRs of the plaintiff / defendant no.1 in counter-claim have been brought on record as LRs of plaintiff in main suit vide order dated 07.05.2025 passed in IA No.11550/2025 and the same may also be brought on record in the counter-claim filed by the defendant no.1/counter-claimant.
5. Heard. There is no dispute regarding factum of death of plaintiff/defendant no.1 in counter-claim. The proposed LRs of plaintiff/defendant no.1 in counter-claim have already been brought on record as his LRs in the main suit in terms of order dated 07.05.2025 passed in IA No. 11550/2025. Right to sue survives in the present counter-claim against LRs of plaintiff/defendant no.1 in counter-claim. In the present facts & circumstances, Mrs. Rajni Rawal (wife), Ms. Malvika Rawal (daughter) and Ms. Madhulika Rawal (daughter) are hereby impleaded as LRs of deceased plaintiff/defendant no.1 in counter-claim and the amended memo of parties filed alongwith the captioned IA is taken on record.
6. The captioned IA stands disposed off accordingly.
