1. This is a significantly large batch of cases involving challenge to two (02) notifications, namely, Notification No.09/2023 dated 31.03.2023 (Central Government) and dated 22.06.2023 (Government of NCT of Delhi), and Notification No.56/2023 dated 28.12.2023 (Central Government) and dated 11.07.2024 (Government of NCT of Delhi).
2. There is no dispute that the validity of both the aforesaid notifications is presently under consideration before the Supreme Court, in view of the divergent views taken by different High Courts.
3. A Division Bench of the High Court of Punjab and Haryana, in



Garg Rice Mill and Ors. v. State of Punjab & Ors.¹ and connected matters, has passed a detailed judgment on 12.03.2025 in this regard.

4. On the aspect of correctness of uploading of Notices to the Assesseees on the web-portal, another judgment has been rendered by the High Court of Punjab and Haryana in ***Luxmi Traders v. Union Territory of Chandigarh & Ors.***² and connected matters,.

5. This Bench has proposed to dispose of the present batch of cases in terms of the aforesaid judgments, while making it clear that the judgment which may be rendered by the Supreme Court shall be binding on all the parties to the present Writ Petitions.

6. In order to facilitate preparation of a comprehensive consolidated chart, Mr. Rajat Mittal, Advocate, on behalf of all the Petitioners, and Mr. Sumit Batra and Mr. Aditya Singla, Advocates, on behalf of the Respondents, are requested to assist the Court.

7. Let a consolidated chart be furnished to this Court for disposal of the present batch of cases.

8. List 11.08.2026 in the Supplementary List.

9. Interim Order dated 31.07.2024 in W.P.(C) 10477/2024 to continue till the next date of hearing.
