I.A. No.10059/2014 under Order XXXIX Rule 2 A CPC moved on behalf of plaintiff

Learned counsel for plaintiff has submitted that present IA has been moved against defendant no.1&2, who are contemnors no.1&2 in the present application and two other persons namely Mr. Asif and Kadeer, who are contemnors no.3&4 in the captioned IA but are not party in the original suit.

Since learned counsel for defendant no.1&2 had not appeared on last date of hearing, therefore, notice of the application is accepted by Learned counsel for defendant no.2 and issue notice of captioned IA to defendant no.1/contemnor no.1 through counsel on filing of PF.
