I.A. No. 3588/2025 (Application seeking directions to attach the property of the defendant and to punish and detain the defendant in civil prison)

1. The present application has been filed under Order XXXIX Rule 2A, read with Section 151 of the Code of Civil Procedure, 1908 ("CPC"), on behalf of the plaintiffs seeking directions against the defendant.
2. Learned counsel appearing for the plaintiffs submits that despite the undertaking made before this Court, the defendant has been wilfully and intentionally flouting its undertaking and orders passed by this Court, and has been advertising the admissions to its school, operating under the name



and brand, “Seth M.R. Jaipuria School, Ballia”.

3. Issue notice.

4. Notice is accepted by learned counsel appearing for the defendant.

5. Mr. Naveen Narad Rai, Trustee of the defendant Trust has appeared before this Court through Video Conferencing (“VC”) and submits that he wishes to resolve the matter with the plaintiffs.

6. On the other hand, learned counsel appearing for the plaintiffs submits that in view of the conduct of the defendant in not paying the requisite fees to the plaintiffs under the terms of the agreement, and in view of the fact that standards are not being maintained by the defendant, the plaintiffs are not interested in carrying out any commercial dealing with the defendant. He, thus, submits that in view of the conduct of the defendant, the agreement with the defendant has already been terminated.

7. At this stage, Mr. Naveen Narad Rai submits that he may be granted an opportunity to approach the plaintiffs in order to explore the possibility of resolving the matter with the plaintiffs.

8. Accordingly, liberty is granted to Mr. Naveen Narad Rai or any other Authorized Representative of the defendant, to approach the plaintiffs in order to resolve the matter.

9. Both the parties are directed to sit together with respect thereto.

10. The defendant is further directed not to send any emails regarding other schools run by the plaintiffs.
