I.A. No. 20794/2025 (seeking discovery and disclosure).

1. Notice in the present IA was issued to defendant nos. 4 to 6 to provide certain details of the registrants. Ld. Counsel for the plaintiff has confirmed that defendant nos. 4 and 5 have supplied the necessary details. There is however no appearance on behalf of defendant no. 6 nor has it supplied any information to ld. Counsel for the plaintiff. It however appears that defendant no. 6 is yet to be served with the notice of the present IA since service report is still awaited. Put up again for further proceedings.

2. Compliance on behalf of defendant no. 2 & 3 has already been recorded in the previous order. Further, compliance on behalf of defendant no. 2 is on record.

3. Ld. Counsel for defendant no. 4 submits that directions given to defendant no. 4, as contained in *para* 39.2 and 39.3 of the order dated 26.08.2025 have been and are being complied with on a continuous basis, which fact has been confirmed by Ld. Counsel for the plaintiff.

4. Affidavit of compliance on behalf of defendant no. 5 is on record now. Service of defendant no. 6 is still awaited.

5. Defendant no. 1 is a John Doe. Although summons were issued to defendant nos. 2 to 6, Hon'ble Court has not issued directions for filing of written statement by these defendants.

6. Defendant no. 7 which has been subsequently impleaded is yet to be served. Service report regarding defendant no. 7 is awaited.

7. Service of defendant no. 6 is also awaited. No written statement is to be filed on behalf of defendant nos. 2 to 5. Defendant no. 1 is a *John Doe*.

8. Matter is already listed before the Hon'ble Court for 19.02.2026. Be placed before the Hon'ble Court on the date already fixed i.e. 19.02.2026, for further directions.
