1. Learned counsel for the applicant seeks to withdraw the present application with liberty to agitate its grievance, if any, against the proposed respondent nos. 3 and 4 in appropriate proceedings. Accordingly, the present application is dismissed as withdrawn with liberty as prayed for.

2. At request of the learned senior counsel for the proposed respondent nos.3 and 4, the strong objection to the present application is taken note of and also the contention that immunity is enjoyed by the respondent no.4 under United Nations (Privileges and Immunities) Act, 1947.

3. In the circumstances, the present application is dismissed as withdrawn, with liberty as prayed for. However, it is made clear that this Court has not commented on the merits of any remedy that may be availed of by the applicant against the proposed respondent nos. 3 and 4.
