seeking exemption from filing apostilled versions of the documents.

1. Heard.
2. In view of submissions of Id. Counsel and grounds mentioned in the application, the application is allowed subject to just exceptions. Defendant no. 19 is granted *six weeks* to file the apostilled versions of the documents / pleadings. I.A. stands disposed off.

I.A. No. 43481/2024 (Order XXXIX Rule 1 and 2 of CPC).

3. Reply on behalf of defendant no. 19 alone is on record. Notice in this IA was also accepted before the Hon'ble Court by defendant no. 31 and defendant no. 28. Ld. Counsel for defendant no. 31 submits that the reply shall be filed as per rules. No reply has been filed by the other defendants. Affidavit of service in regard to the present IA is yet to be filed. Let the same be filed within three weeks.

I.A. No. 35165/2024 filed on behalf of defendant no. 22 for its deletion.

4. Reply on behalf of the plaintiff still appears to be under objections. Ld. Counsel is directed to take steps within two weeks to bring the reply on record failing which right to bring the reply on record shall stand closed without any further orders.

5. Vide order dated 11.11.2024, suit has been decreed against defendant no. 42.



6. Ld. Counsel for defendant no. 13 submits that settlement proposal has been shared with the plaintiff's counsel and they are awaiting a revert from the plaintiff. However, ld. Counsel for the plaintiff submits that she has no instructions in this regard.

7. Ld. Counsel for defendant no. 16 submits that a copy of the amended plaint has not been supplied for which reason the amended written statement has not been filed till date. Let the amended plaint be supplied today itself on the email of Ld. Counsel for defendant no. 16. Amended written statement be filed thereafter as per rules.

8. Amended written statement on behalf of defendant no. 19 is on record.

9. Ld. Counsel for defendant no. 20 submits that they have complied with the directions passed by the Hon'ble Court on various hearings. Ld. Counsel further submits that amended written statement shall be filed to the amended plaint, as per rules and if required.

10. Ld. Counsel for defendant no. 28 submits that compliance has been carried out of the directions of the Hon'ble Court.

11. Ld. Counsel for defendant no. 31 submits that compliance has been carried out of the directions of Hon'ble Court's order dated 28.10.2024. Ld. Counsel further submits that written statement to the amended plaint shall be filed as per rules.

12. Defendants no. 32 to 45 are yet to be formally served. Summons on behalf of defendant no. 31 were accepted before the Hon'ble Court on 28.10.2024. Ld. Counsel for the plaintiff is directed to take necessary steps in regard to service of unserved defendants.

13. Ld. Counsel for defendant no. 41 has also put in appearance and accepts summons. He further submits that



inadvertently in the vakalatnama has been mentioned that the vakalatnama is on behalf of defendant no. 42 but infact it is on behalf of defendant no. 41. Submission is noted for records.

14. Put up for completion of pleadings on 05.02.2025.
