1. The present execution petition has been filed seeking execution of the decree/judgment dated 09.04.2025, as corrected by order dated 29.04.2025, passed by this Court in CS(COMM) 677/2023. The decree is for an amount of Rs.4,70,63,169.61 along with interest at the rate of 24% per annum from the date of institution of suit i.e. 25.09.2023 till realization.
2. In the prayer clause of the present petition, it is stated that the amount along with up to date interest at the time of filing of execution petition was Rs.6,87,13,225/-.
3. Attention of the Court has been drawn to the order dated 23.03.2026 passed by the learned Joint Registrar, wherefrom it is borne out that the judgment debtor has been served. However, neither there is appearance on behalf of the judgment debtor nor the affidavit of assets in terms of order



dated 04.09.2025 passed by this Court has been filed by the judgment debtor.

4. In view of the above, the account of judgment debtor viz. Account No.006505006293 maintained with ICICI Bank at its Branch at 158 B3, Kishangarh Vasant Kunj, Delhi-110070 [IFSC : ICIC0004167] is attached in the sum of Rs.6,87,13,225/-.

5. The aforesaid branch of ICICI Bank is accordingly, directed to debit freeze the account of the judgment debtor.

6. The judgment debtor is stated to be the LLP. The print out from the website of Ministry of Corporate Affairs has been handed over across the Bar to submit that one, Mr. Sudhir Binjola and Ms. Sugandha Thapliyal, are partners of the said LLP.

7. Since there is no appearance on behalf of the judgment debtor, issue bailable warrants in the sum of Rs.25,000/- against the aforesaid two partners of the said LLP i.e. Mr. Sudhir Binjola and Ms. Sugandha Thapliyal to be executed through the SHO concerned.

8. The decree holder is at liberty to furnish the addresses of the aforesaid two partners of the LLP for the purpose of execution of bailable warrants.

9. Re-notify on 28.10.2026.
