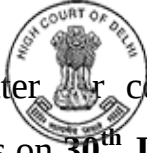
4. It was already submitted on behalf of defendants no.1 to 3 that they did not wish to file any reply to the captioned IA and have no objection if the same is allowed.

6. No written statement, affidavit of admission/denial of documents and reply to the captioned IA has been filed on behalf of defendant no.4.
7. Ld. Counsel for plaintiff submits that statutory period for filing written statement, affidavit of admission/denial and reply to the captioned IA by defendant no.4 has already expired and hence, right of defendant no.4 to file the same may be closed.
8. Heard. Perusal of record would show that summons of the suit issued to the defendant no.4 by ordinary mode were served on 04.11.2024. No written statement and affidavit of admission/denial of documents has been filed on behalf of defendant no.4 till date.
