1. It is submitted that the captioned IA is coming up for
hearing before the Hon'ble Court on 21.05.2025.

**I.A. No. 48280/2024 (by defendants for condonation of
delay of 44 days in filing WS and affidavit of admission/
denial of documents)**

2. As per office noting, reply to the captioned IA has been
filed on behalf of the plaintiff.

3. Ld. Counsel for defendants has submitted that he does not
wish to file any rejoinder to the said reply.

4. Pleadings qua the captioned IA are complete.

5. At this stage, Ld. Counsels for both the parties have
submitted that they have no objection if delay in filing



written statement on behalf of defendants is condoned subject to some reasonable cost.

6. Heard. For the reasons stated in the application and in view of the above submissions, delay in filing written statement on behalf of defendants is condoned and the same be taken on record if complete in other respects, subject to cost of Rs.3,000/- to be paid to the plaintiff. Cost not paid, same be paid on or before the next date.
7. The captioned IA stands disposed off accordingly.
