1. A request is made on behalf of counsel for petitioner on the ground that the main arguing counsel is not available, on ground of personal difficulty; counsel for respondent has no objection since the adjournment is being sought on personal difficulty.

2. While CO (COMM IPD-PAT) 4/2023, was filed by petitioner seeking revocation of the patent granted in favour of respondent being IN 284903 (*'impugned patent'*), a counter suit was subsequently filed by respondent, being CS(COMM) 456/2023, alleging infringement of the suit patent by petitioner/defendant. The status of applications which are pending in the suit are as under:

- i. I.A. 12412/2023, application filed by plaintiff under Order XXXIX Rules 1 and 2 of Civil Code of Procedure, 1908 ("**CPC**") – *Pleadings are complete.*
 - ii. I.A. 20475/2023, application filed by plaintiff under Order VI Rule 17 of CPC – *Pleadings are complete.*
 - iii. I.A. 22866/2023, application filed by defendant to take on record documents with the additional written statemen- *Pleadings are incomplete.*
 - iv. I.A. 23176/2023, application filed by defendant to condone delay in filing the additional written statement – *Pleadings are incomplete.*
 - v. I.A. 24284/2023, application filed by defendant under Order VII Rule 10 and 11 of CPC for return /rejection of the plaint- *Pleadings are complete.*
3. Parties are directed to complete the pleadings. The matter is already listed before the Joint Registrar on 30th May, 2024.
