I.A. No. 9850/2024 (Counter Claim No. 1/2024) seeking condonation of delay of 56 days in filing the written statement to counter claim filed by the counter claimant no. 1 and 2.

1. Ld. Counsel for the plaintiff submits that if the application is to be allowed, same may be subject to imposition of a reasonable cost.
2. For the reasons stated in the application, application is allowed subject to cost of Rs. 500/-, to be deposited with Delhi High Court Bar Clerks Association, Delhi High Court within three weeks failing which the written statement shall be deemed to have been taken off the record. Delay stands condoned. Written statement is taken on record. Replication be filed within the period permissible, as worked out from today. IA stands disposed off.

3. Reply on behalf of defendant no. 4 has been filed but is stated to be under objection on account of delay which is of one day only. Ld. Counsel for the plaintiff has no objection if on the oral request of Ld. Counsel for defendant no. 4 the delay is condoned. Consequently, the delay in filing the reply on behalf of defendant no. 4 is condoned. Registry is directed to take the same on record. IA is disposed off.
