1. The present application has been filed under Section 151 of the Code of Civil Procedure, 1908 ("CPC"), seeking exemption from filing certified copy of the documents being filed along with the petition.
2. Exemption allowed, subject to all just exceptions.
3. Application is accordingly disposed of.

4. The present application has been filed under Section 151 of the CPC, on behalf of the petitioner, seeking early hearing of the captioned matter.
5. Learned counsel appearing for the petitioner submits that a notice for



recovery of Rs. 15,77,712/- (Rupees Fifteen Lacs Seventy-Seven Thousand Seven Hundred Twelve Only), was issued on 04th June, 2026, by Sub-Divisional Magistrate (“SDM”), Badarpur, Government of NCT of Delhi (“GNCTD”), followed by Warrant of Attachment dated 24th June, 2026, to recover the said amount, which has been received by the petitioner on 30th June, 2026.

6. It is submitted that respondent no. 1 was gainfully employed during the relevant period, and the same has been concealed by respondent no. 1. Further, it is submitted that, in case, the said Warrant of Attachment is allowed to be executed, the present petition would become infructuous.

7. Thus, the present application has been filed.

8. Issue notice. Notice is accepted by learned counsel appearing for respondent no. 2.

9. Issue notice to respondent no. 1, by all modes.

10. Let reply be filed, within a period of two weeks.

11. Rejoinder thereto, if any, be filed within a period of one week, thereafter.

12. Considering the submissions made before this Court, it is directed that the Warrant of Attachment dated 24th June, 2026, as issued by the *Office of Assistant Collector Grade-I/SDM (Badarpur), 37, Tughlakabad Institutional Area, New Delhi-110062*, shall remain stayed, till the next date of hearing.

13. List on the date already fixed, i.e., 18th August, 2026.
