1. Allowed, subject to all just exceptions.
2. Applications stand disposed of.

3. By way of the present petition, the petitioners seek the following reliefs:

“a. seeking quashing of the charge-sheet dated 16.08.2018 filed in connection with FIR No. 95/2016 dated 17.06.2016, registered under Sections 406, 420, 468, 471, 477A, and 120B of the Indian Penal Code, 1860, at Police Station Economic Offences Wing (EOW), District EOW, New Delhi, and Criminal Case No. 26725 of 2018 arising out of the said FIR, which is presently pending before the Court of the Learned Chief Metropolitan Magistrate, South-West District, Dwarka Courts, New Delhi, and all other proceedings arising out of the said FIR; and



b. direct the release of the amount of ~17,50,000/- (Rupees Seventeen Lakhs Fifty Thousand only), deposited by the Petitioners in compliance with the order dated 15.01.2024 passed in Crl. M.C. No. 1551 of 2023, in favour of Respondent No. 2, in the interest of justice and to give full effect to the terms of the settlement; and”

4. Issue notice. The learned APP accepts notice on behalf of the State and the learned counsel accepts notice on behalf of respondent no. 2. They seek time to file the Status Report/reply. Let the same be filed, before the next date of hearing, with an advance copy to the other side.
5. Let the Trial Court Record, in digitized form, be called for, at least two days prior to the next date of hearing.
6. List on 05.12.2025.
7. In the meantime, in view of the settlement arrived at between the parties, the proceedings pending before the learned Trial Court are stayed.
8. The order be uploaded on the website forthwith.
