CS(COMM) 893/2024 and I.A. 26062/2025

1. Plaintiff and Defendant No.1 have amicably settled their *inter se* disputes and only some modalities remain to be completed. Right of Defendant No. 2 to file written statement was closed on 02.02.2026 and of Defendants No. 3 and 4 was closed on 17.12.2025. There is no appearance on behalf of Defendants No. 3 and 4 after service of summons and none appears today. It appears that the said Defendants are not interested in contesting the suit and are set *ex parte*.

2. Counsel for Defendant No.2 seeks time to revert with instructions if Defendant No. 2 is willing to settle the matter with the Plaintiff.

3. At request, list on 30.04.2026.

4. Issue notice to Defendants No. 6-9 through all permissible modes, returnable on 30.04.2026.



5. By order dated 09.10.2024, Court granted *ex parte* ad interim injunction restraining Defendants No.1 to 4 *inter alia* from infringing Plaintiff's copyright in photograph/images uploaded on the website etc., as also in the artistic works/garments, amongst other. On coming across other infringing links, Plaintiff filed I.A. 43675/2024 and by order dated 28.10.2024, Court extended order dated 09.10.2024 to newly identified 51 links/John Does. Present application has been filed as other links have been discovered by the Plaintiff, which are infringing his copyright.

6. After hearing learned counsel for the Plaintiff, I am of the view that Plaintiff has made out a *prima facie* case for grant of *ex parte* ad interim order against Defendants No. 6, 7 and 9 and balance of convenience also lies in favour of the Plaintiff and accordingly, there is no impediment in extending the *ex parte* ad interim order dated 09.10.2024 to Defendants No. 6, 7 and 9.

7. Accordingly, Defendant No. 6 is directed to take down the URL mentioned at Serial No. 1 in **Annexure 'A'** to this order. Defendant No. 7 is directed to take down URLs at Serial Nos. 2-9 in **Annexure 'A'** and Defendant No. 9 shall take down URL at Serial No. 11 in **Annexure 'A'**. The needful shall be done within 48 hours from the date of receipt of this order.

8. As per office report, service report is awaited. Issue fresh notice to Defendants No. 1-5 through all permissible modes, returnable on 30.04.2026.
