1. Plaintiff has filed the present Application under Order XXXIX Rule 2A read with Section 151 of the Code of Civil Procedure, 1908 for reporting wilful disobedience of the order dated 22.09.2025 by the Defendant / Contemnor.

2. *Vide* order dated 22.09.2025, the Defendant / Contemnor was directed as under:

“25. Accordingly, till the next of hearing, it is directed as under:

i. *The Defendant, his partners, associates, assigns or assignees in interest, heirs, successors or successors in interest, permitted assigns, distributors, dealers, wholesalers, retailers, stockiest, agents and all others acting for and on their behalf are restrained from using, soliciting, manufacturing, selling, offering for sale, importing, exporting and advertising in any manner including on the internet and e-commerce platform, directly or indirectly, dealing in mobile accessories under the Plaintiff's Mark 'Rezoni' so as to cause infringement or passing off of the Plaintiff's Mark.*

ii. *The Defendant, his partners, associates, assigns or assignees in interest, heirs, successors or successors in*



interest, permitted assigns, distributors, dealers, wholesalers, retailers, stockiest, agents and all others acting for and on their behalf are restrained from using, soliciting, manufacturing, selling, offering for sale, importing, exporting and advertising in any manner including on the internet and e-commerce platform, directly or indirectly, dealing in mobile accessories under the Plaintiff's Artistic Works including but not limited to the ones specifically described in Schedule A of the Plaint.

iii. The Defendant shall take down, remove, disable and block the material infringing upon the Plaintiff's Artistic Works, including but not limited to the Infringing Material described in Schedule B and Schedule C of the Plaint within 72 hours of receiving the Notice and copy of this Order along with copy of Schedule B and Schedule C."

3. The learned Counsel for the Plaintiff submits that Defendant / Contemnor has wilfully disobeyed and not complied with all the directions passed by this Court against the Defendant in the order dated 22.09.2025. The learned Counsel for the Plaintiff submits that during the execution of the Local Commission on 29.09.2025, the entire paper book along with copy of the order dated 22.09.2025 was provided to the Defendant / Contemnor and, therefore, the Defendant / Contemnor is fully aware about the passing of the order dated 22.09.2025.

4. The learned Counsel for the Plaintiff submits that Defendant / Contemnor is still displaying the Plaintiff's copyrighted works on Defendant / Contemnor's website and is communicating to the public through various posts on social media and through advertisements which is clearly in violation of the order dated 22.09.2025.

5. The Plaintiff has also provided the screenshots of the Defendant / Contemnor's website as well as social media posts put by the Defendant / Contemnor in order to substantiate that the order dated 22.09.2025 passed by



this Court is violated / disregarded by the Defendant / Contemnor.

6. Issue Notice.

7. Let Notice be served upon Defendant / Contemnor through all permissible modes including *dasti* on filing of process fee. The Defendant / Contemnor shall remain personally present in the Court to explain the wilful disobedience and disregard of the directions contained in the order dated 22.09.2025 on the next date of hearing.

8. Let Reply to this Application be filed within a period of two weeks from date. Rejoinder thereto, if any, be filed within one week thereafter.

9. In the meanwhile, the Defendant / Contemnor is directed to strictly comply with the order dated 22.09.2025.
