4. The petitioners claim to be bank officials and similarly placed as the co-accused Ashok Kumar Gupta, who has already been discharged by this Court by judgment dated 14.08.2025 passed in CRL.M.C. 194/2019.

7. The petitioners are at liberty to file a chart indicating that the role of the petitioners is similar to co-accused Ashok Kumar Gupta.
