1. Today the captioned IAs are listed for arguments.
2. It is submitted that the matter is coming up for hearing before the Hon'ble Court on 10.02.2025. It is further submitted that evidence is being recorded in the present matter by Ld. Local Commissioner.
3. As per office noting, nothing fresh has been filed.
4. Ld. Counsel for plaintiff has submitted that the plaintiff has no objection if the Notification dated 11.09.2012 is taken on record and he is not disputing the contents and



genuineness of the said Notification, copy of which has already been exhibited as Ex.PW1/D8. He has further submitted that the plaintiff is also not disputing contents and genuineness of the certified copies of registered documents i.e. Mark PW1/D1, Mark PW1/D2, Mark PW1/D3, Mark PW1/D4 and Mark PW1/D6, Mark PW1/D7 as well as Mark PW1/D8. Statement of plaintiff has been recorded in this regard.

5. Heard. In view of above submissions, Notification dated 11.9.2012, which is already exhibited as Ex.PW1/D8 is taken on record. IA No.41630/2024 stands disposed off accordingly.

Further, in view of statement of the plaintiff, the above said documents i.e. Mark PW1/D1, Mark PW1/D2, Mark PW1/D3, Mark PW1/D4, Mark PW1/D6 as well as Mark PW1/D7 are being exhibited as Ex.PW1/D1, Ex.PW1/D2, Ex.PW1/D3, Ex.PW1/D4, Ex.PW1/D6 and Ex.PW1/D7, respectively and the document Mark PW1/D8 is being exhibited as Ex.PW1/D8A.
7. Ld. Counsel for defendant has submitted that since the above said documents have been admitted by the plaintiff and the same have been exhibited, therefore, he does not wish to proceed further with his IA No. 41629/2024 and intends to withdraw the same.
8. In view of above submissions, IA no. 41629/2024 is dismissed as withdrawn.
9. Both IAs stand disposed off accordingly.
