**CRL.M.A. 1158/2025(Application under Section 528 of the BNSS, 2023
for impleadment of Inspector of New Ashok Nagar Police Station, New
Delhi)**

1. This is an application filed under Section 528 of the Bharatiya Nagrik Suraksha Sanhiyta, 2023 (BNSS) for impleading Station House Officer (SHO), PS New Ashok Nagar, New Delhi as a Respondent no. 4 in the present petition.
2. Learned Senior Counsel for the Petitioner states that Respondent No. 4 is a proper party and relies upon the reply dated 04.05.2024 filed by the concerned Inspector of PS New Ashok Nagar, Delhi before the



Karkardooma Courts.

3. Keeping in view that the matter is at the nascent stage as no notice has been issued in the main writ petition, application is allowed and the SHO, PS New Ashok Nagar is impleaded as a party i.e. Respondent no. 4.

4. The Petitioner is directed to file an amended memo of parties within one (1) week.

5. Accordingly, the application stands disposed of.

6. Learned Senior Counsel for the Petitioner states that no amendment to the writ petition is to be made on account of this impleadment. The said statement is taken on record.

7. This is an application filed by the Petitioner for placing on record additional documents.

8. Keeping in view the fact that the present petition is at the nascent stage, the application is allowed and the documents are taken on record.

9. Issue notice. Learned ASC for State accepts notice on behalf of newly impleaded Respondent No. 4.

10. Issue notice to Respondent nos. 1 to 3 through resident Commissioner.

11. In addition, the SHO PS New Ashok Nagar shall ensure that a communication with respect to the pendency of these proceedings is communicated to the Inspector of Ramji Nagar Police Station, Trichy, Tamil Nadu i.e., Respondent no. 3.

12. The newly impleaded Respondent No. 4 is directed to file their Status



Report two (2) days prior to the next date of hearing.

13. Respondent Nos. 1 and 2 as well are directed to file a Status Report two (2) days prior to the next date of hearing.

14. In view of the fact that allegations made in the petition are specifically against Respondent no. 3 personally, Respondent no. 3 is directed to file a counter affidavit under his own signatures two (2) days prior to the next date of hearing.
