6. Written statement shall be filed by the Defendants No. 1 and 2 within 30 days along with affidavit of admission/denial of the documents filed by the Plaintiffs.
7. It is open to the Plaintiff to file replication within 30 days from receipt



of the written statement along with affidavit of admission/denial of documents filed by the Defendants No. 1 and 2.

8. Upon filing of process fee, issue summons to remaining Defendants, through all permissible modes.

9. Written statement shall be filed by remaining Defendants within 30 days from the receipt of summons along with affidavit of admission/denial of the documents filed by the Plaintiff.

10. It is open to the Plaintiff to file replication within 30 days from receipt of the written statement along with affidavit of admission/denial of documents filed by remaining Defendants.

11. If any of the parties wish to seek inspection of any documents, the same be done in accordance with Delhi High Court (Original Side) Rules, 2018.

12. List before the learned Joint Registrar for completion of service and pleadings, marking of exhibits and admission/denial of documents on 10.12.2025.
