1. Learned Senior Counsel appearing for the Indian Golf Union has brought to the notice of this Court an order dated 09th September, 2025, passed by the Division Bench-I in *LPA No. 565/2025*, titled as *Indian Olympic Association Versus Indian Golf Union & Anr.*, to submit that the other matter, i.e., *W.P.(C) 12004/2025* pending before this Court, is to be heard along with the batch of *W.P.(C) 898/2025*, *W.P.(C) 1407/2025* and *W.P.(C) 3092/2025*.



2. This Court further notes that a fresh writ petition being W.P.(C) 15664/2025 has been filed on behalf of the Indian Golf Union.
3. Considering the order passed by the Division Bench-I of this Court in LPA No. 565/2025, the fresh petition, i.e., W.P.(C) 15664/2025 shall also be heard along with these batch of matters.
4. This Court is informed that reply has been filed in W.P.(C) 12004/2025. However, the same is not on record.
5. Let steps be taken to have the said reply placed on record.
6. The petitioner is directed to file rejoinder in W.P.(C) 12004/2025, within a period of two weeks, from today.
7. W.P.(C) 15664/2025 is a fresh petition and is listed for the first time.
8. Accordingly, issue notice. Notice is accepted by the respondents.
9. Let reply be filed by the respondents within a period of three weeks. Rejoinder thereto, if any, be filed within a period of one week, thereafter.
10. Mr. Dayan Krishnan, learned Senior Counsel for the respondent no. 2, i.e., Indian Golf Union, in W.P.(C) 898/2025 has commenced his arguments.
11. For further arguments, re-notify on 07th November, 2025 and 10th November, 2025.
