The present petitions under Section 528 of Bharatiya Nagarik Suraksha Sanhita, 2023 (formerly 482 of the Code of Criminal Procedure) seek quashing of the order dated 14th July, 2025 passed by Special Judge (PC Act), CBI-20, Rouse Avenue Court, New Delhi, whereby charges under Section 120-B of the Indian Penal Code, 1860¹ read with Sections 11, 13(1)(d) and 13(1)(2) of the Prevention of Corruption Act, 1988² have been framed against Sudhir Kumar Jain, while charges under Sections 120-B of the IPC read with Section 12 of the PC Act have been framed against Vineet Godha and Purushottam Totlani in Case No. CBI No. 161/2019.
