CCP(O) 125/2025

1. The present contempt petition has been filed on behalf of the defendants no.1 to 3 seeking initiation of contempt proceedings against the respondent no.1 (plaintiff) and the respondent no.2 (ICICI Bank).
2. Ms. Rashmi Chopra, senior counsel appearing on behalf of the plaintiff, submits that the plaintiff did not instruct ICICI Bank (respondent no.2) to freeze the bank accounts of the defendant no.2.



3. Having heard counsel for the parties, including counsel appearing on behalf of ICICI Bank, a direction is issued to ICICI Bank to forthwith defreeze the bank accounts detailed in paragraph 10 of the present petition, which are set out below:

4. The petition stands disposed of with the aforesaid directions.

CS(OS) 741/2025 and I.A. 25853/2025 (u/O-XXXIX Rules 1 & 2 of the CPC)

5. It is clarified that the order passed by this Court on 16th October, 2025 granting *status quo* in relation to movable and immovable properties of the



deceased Syed Habeeb Ur Rehman would not come in the way of operation of the bank accounts of the defendants no.1 to 3.

6. However, the defendants no.1 to 3 are directed to provide details of the holders of the aforesaid bank accounts and further directed to file with this Court up-to-date monthly bank statements in respect of all the aforesaid bank accounts from 16th October, 2025 till date and continue filing monthly bank statements for the subsequent period till further orders.

7. List on 23rd March, 2026, the date already fixed.
