1. Replies on behalf of Defendant Nos. 1 to 3 and Defendant Nos. 6 to 10 are already on record.
2. The plaintiff has filed rejoinders to both the replies. However, the same have been returned under office objections.
3. Applications seeking condonation of delay in filing and re-filing the said rejoinders are pending adjudication.

28. It is further submitted that the delay in filing the replications to the joint written statements of Defendant Nos. 1 to 3 and Defendant Nos. 6 to 10 is only 14 days.

29. In view of the submissions made and the no-objection given by learned counsel for Defendant Nos. 1 to 3 and Defendant Nos. 6 to 10, the delay in filing the replications to the joint written statements of Defendant



Nos. 1 to 3 and Defectual Nos. 6 to 10 is condoned.

30. Accordingly, IA Nos. 10042/2026 and 10043/2026 stand disposed of.
