1. We are informed by Ms. Monika Arora, Id. Standing Counsel appearing for South Delhi Municipal Corporation (SDMC), East Delhi Municipal Corporation (EDMC) and North Delhi Municipal Corporation (NDMC) that on account of some miscommunication and misunderstanding, the order dated 29th January, 2018 passed in W.P.(C)No.784/2018 has not been complied with.

2. We are informed by Ms. Vibha Mahajan Seth, Advocate, who was appointed as one of the counsels directed to assist the Committee appointed by us that in para 21 of our order dated 29th January, 2018 (recorded in W.P.(C)No.784/2018), directions have been issued to New Delhi Municipal Council to provide suitable office space in the Headquarters. Ms. Monika Arora, Id. Standing Counsel for the Municipal Corporations prays for a short adjournment to take instructions in this regard.

4. Ms. Vibha Mahajan Seth, Advocate may also apprise Ms. Monika Arora, Id. Standing Counsel about the facilities which are already made available.

5. All the respondents shall inform the names of the nodal officers who shall represent them before the Committee. This information be furnished to counsels for the Committee.
