1. The present application has been filed on behalf of the respondent to bring on record subsequent developments.
2. Learned counsel appearing for the respondent submits that the respondent had filed an application, being *CM APPL. 50539/2026*, in the present proceedings, seeking permission to deposit the amount claimed by the petitioner before this Court.
3. It is submitted that in *paragraph 6* of the said application, the



respondent has specifically stated that though the Division Bench had pronounced the order on 31st July, 2026, with regard to the application, being *CM APPL. 5096/2026* in *LPA 941/2024*, however, the said order had not been uploaded on the official website of this Court as on date of listing of *CM APPL. 50539/2026*.
