I.A. 46079/2024 (Exemption from filing certified copies of documents)

1. The present is an application under Section 151 of the Code of Civil Procedure, 1908 ("CPC"), on behalf of the plaintiffs, seeking exemption from filing certified copy, typed copies of the annexures.



2. Exemption is granted, subject to all just exceptions.
3. Plaintiffs shall file legible, clear, and translated copies of the documents, on which the plaintiffs may seek to place reliance, before the next date of hearing.
4. Accordingly, the present application is disposed of.

I.A. 46078/2024 (Exemption from instituting Pre-Institution Mediation)

5. The present is an application under Section 12A of the Commercial Courts Act, 2015, read with Section 151 of CPC, seeking exemption from undergoing Pre-Institution Mediation.
6. Having regard to the facts of the present case and in the light of the judgment of Supreme Court in the case of *Yamini Manohar Versus T.K.D. Keerthi*, 2023 SCC OnLine SC 1382, and Division Bench of this Court in *Chandra Kishore Chaurasia Versus RA Perfumery Works Private Ltd.*, 2022 SCC OnLine Del 3529, exemption from attempting Pre-Institution Mediation, is granted.
7. Accordingly, the application stands disposed of.

I.A. 46076/2024 (Application seeking leave to file additional documents)

8. This is an application under Order XI Rule 1(4) read with Section 151 CPC as amended by the Commercial Courts Act, 2015, seeking leave to file additional documents.
9. The plaintiffs, if wish to file additional documents at a later stage, shall do so strictly as per the provisions of Commercial Courts Act, 2015 and the Delhi High Court (Original Side) Rules, 2018.
10. The application is disposed of, with the aforesaid directions.

I.A. 46077/2024 (Exemption from advance service to the defendant nos. 1 to 5 and 10)



11. The present is an application under Section 151 CPC, seeking exemption from advance service to the defendants.

12. The plaintiffs seek urgent interim relief, and have also sought appointment of Local Commissioner. Therefore, in the peculiar facts and circumstances of this case, exemption from effecting advance service upon the defendant nos. 1 to 5 and 10, is granted.

13. For the reasons stated in the application, the same is allowed and disposed of.

CS(COMM) 1045/2024

14. Let the plaint be registered as suit.

15. Issue summons.

16. Summons is accepted by learned counsel appearing for defendant no. 6 and 9.

17. Upon filing of the process fee, issue summons to the other defendants by all permissible modes. Summons shall state that the written statement be filed by the defendants within thirty days from the date of receipt of summons. Along with the written statement, the defendants shall also file affidavit of admission/denial of the plaintiffs' documents, without which, the written statement shall not be taken on record.

18. Liberty is given to the plaintiffs to file replication within thirty days from the date of receipt of the written statement. Further, along with the replication, if any, filed by the plaintiffs, an affidavit of admission/denial of documents of the defendants, be filed by the plaintiffs, without which, the replication shall not be taken on record. If any of the parties wish to seek inspection of the documents, the same shall be sought and given within the timelines.



19. List before the Joint Registrar (Judicial) for marking of exhibits, on 20th January, 2025.

20. List before the Court on 08th April, 2025.

I.A. 46074/2024 (Application under Order XXXIX Rules 1 and 2 CPC)

21. The present suit has been filed for permanent injunction restraining infringement of trademark and copyright, trademark and product, trade dress, shape of goods, passing off, unfair trade practice, rendition of accounts, directions, damages and other related reliefs.

22. Learned counsel appearing for the plaintiffs submits that the present suit is being filed by the plaintiffs to *inter alia* restrain the defendant nos. 1-5, 10-11 from using and dealing with the mark



KLUSTER/ for any game infringing the trademark of the plaintiffs and further infringing the copyright of the plaintiffs residing in its product packaging/trade dress/label; manufacturing, sourcing, packaging and selling counterfeit products and passing off their goods as well their shape of the goods as that of the plaintiffs. Further, the present suit is being filed by the plaintiffs against the defendant nos. 6-9 to restrain them from listing counterfeit products on their E-Commerce platforms and related reliefs.

23. It is submitted that the plaintiff no. 1, Kluster LLC, is an entity based in United States and was formed in the year 2018. It is submitted that in and around the year 2006, the directors of plaintiff no.1, Robert & Paula Henning designed certain games for children—specifically magnetic dexterity game. Eventually, these were improved and in or around the year 2016, one of the directors of plaintiff no.1, Mr. Robert Henning coined the mark -



KLUSTER for the magnetic game developed for children. The rights in respect of the mark KLUSTER were assigned in favour of plaintiff no. 1 vide Assignment deed dated 05th February, 2019 and 12th October, 2020. Plaintiff no. 1 adopted the mark KLUSTER for manufacturing and sale of various games, specifically magnetic dexterity game, popularly known as KLUSTER, in the domestic markets of United States. Being a coined word, the mark instantly became popular among the public and gained wide market acceptance and popularity. Since then, the mark KLUSTER is the prominent part of the corporate identity of plaintiff no. 1.

24. It is further submitted that the plaintiffs joined hands together in order to manufacture and sell the product under the mark KLUSTER along with



logo . The International Licensing Agreement entered into between plaintiff nos. 1 and 2 dated 05th August, 2019 is being filed along with this suit. By virtue of the said Licensing Agreement, plaintiff no. 2 has been granted rights to use the Intellectual Property Rights of plaintiff no. 1, with respect to magnetic games.

25. It is submitted that in view of the immense popularity gained by KLUSTER magnetic dexterity game, plaintiff no. 1 in the year 2019, applied for and was granted a Patent being US 10,967,247 B1 titled '*Game Utilizing Magnetic Forces*' in the favour of plaintiff no. 1 on 06th April, 2021.

26. It is further submitted that considering the success of the KLUSTER magnetic dexterity game in many parts of the world, plaintiffs on or around 25th November, 2021 introduced the product in the markets of India, under



the mark and logo KLUSTER and . In fact, since then the mark



KLUSTER has been in use extensively, uninterruptedly and continuously PAN-India. The said product of the plaintiff no. 1 is sold through plaintiff no.2 through their official website. In India, plaintiff no.1 has appointed a sole distributor based in Chennai and has no other franchisees or distributors.

27. It is submitted that the plaintiff no. 1 has extensive social media presence with its exclusive pages/accounts on platforms like Facebook, Instagram and YouTube.

28. It is further submitted that the plaintiffs have been extensively advertising its mark “KLUSTER” and associated logo through various media including print and broadcasting. By virtue of such extensive advertising/promotion and continuous use, the mark “KLUSTER” and the associated logo is associated in the minds of the public, only with the plaintiffs and none else.

29. It is submitted that the game under the mark KLUSTER has been featured on a TV Show, NCIS Los Angeles and thereafter has been awarded 2020 Toy of the Year (Jouet De L’Annee) and further nominated for 2021 Les Palmes des jeux in Canada. It is submitted that the game under the mark KLUSTER has also gained immense popularity among its Indian consumers. The details of the trademark registrations in India of the plaintiffs, are reproduced as below:-

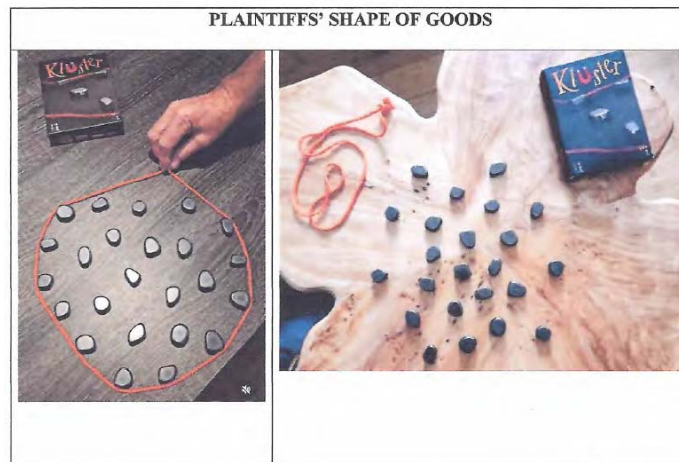
30. It is further submitted that the Magnetic Dexterity game, popularly known as KLUSTER, is sold in a distinctive packaging under a unique label which were created by Mr. Mathieu NEHEMIE in the year 2019. The product packaging including the size, features, layout and the label are so unique that the same is only associated with the plaintiffs. The label created by the plaintiffs is eye-catching and hence is well-recognized among the public. A sample of the product packaging of the game sold under the mark KLUSTER by the plaintiffs and the label is reproduced as below:





31. It is submitted that the distinct and unique visual features of the aforesaid magnetic game sold under the mark KLUSTER, the packaging including the label constitute original “artistic work” within the meaning of Section 2 (c) of The Copyright Act, 1957, which has been designed by Mr. Mathieu NEHEMIE. The said artistic work has been assigned to and in favour of plaintiff nos. 1 and 2 vide an Assignment deed dated 08th November, 2024. He submits that the plaintiff nos. 1 and 2, are therefore, the owners of the copyright in magnetic game packaging as well as the label under the mark KLUSTER, thus having exclusive right to use or reproduce the same in any material form. Any unauthorized use, reproduction of the label as well as the product packaging of magnetic game under the mark KLUSTER or a copy thereof, amounts to infringement of copyright of the plaintiffs in the said packaging and the label thereof.

32. It is further submitted that KLUSTER is one-of-a-kind game whereby even the contents of the game are specifically designed and created by Robert and Paula Henning, the founder of plaintiff no. 1. One of the contents of the game is a set of 28 hematite magnets, each of these magnets have different shapes and sizes are carefully designed and are created such by plaintiff no. 1. A visual representation of these magnets, in the game sold under the mark KLUSTER is reproduced as below:



33. It is submitted that from the aforesaid it can be inferred that each magnet in the plaintiff's game sold under the mark KLUSTER has a different shape and size. Each of these magnets and the rope are designed by plaintiff no.1 and by virtue of such design, the shape of the goods is unique to plaintiff no.1 and it along with plaintiff no.2 has the exclusive right to use the same. It is submitted that shape of goods is protected under the Trade Marks Act, 1999 and anyone; imitating and using the shape of goods of the plaintiffs, without authority commits an act of passing-off.

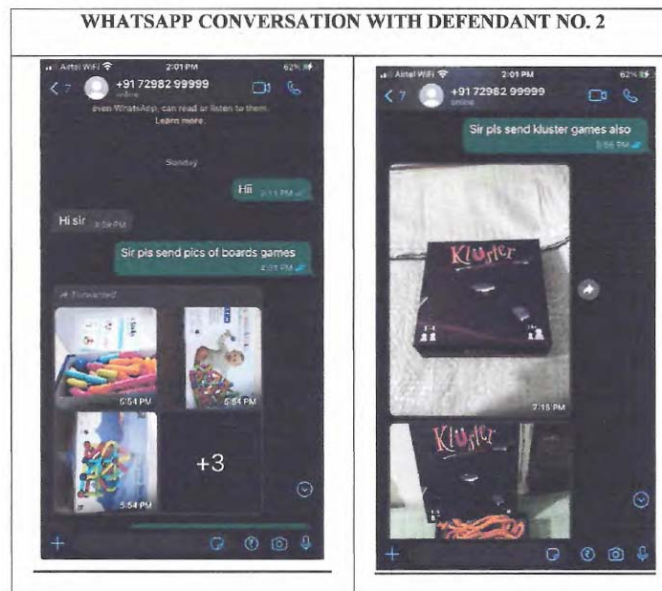
34. It is further submitted that in and around January, 2024, the plaintiffs while conducting a public search for its trademarks, came across a

trademark application filed for the mark  under the TM application no. 6243717 dated 03rd January, 2024, by one Mr. Deval Ravindrabhai Bambhaniya, i.e., defendant no. 1 herein. On further research, the plaintiffs came across a website www.kluster.in wherein counterfeit products of the plaintiffs were being sold. Having noticed the infringing products, the plaintiffs decided to warn the defendants of the wrongful activities. In view thereof, the plaintiffs sent a cease-and-desist notice to defendant no. 1 on 13th February, 2024. Pursuant to the same, defendant no.1



not only withdrew the TM application no. 6243717 but also took down his website www.kluster.in. With this, it was assumed that the matter stood closed and defendant no. 1 would have ceased his infringing activities.

35. It is submitted that in and around May, 2024, the plaintiffs came across an entity Wow Bag, which was listed on IndiaMart, i.e., defendant no.8 selling kids toys. On investigation, Wow Bag turned out to be a proprietorship concern run by Mr. Hardik Kotecha, i.e., defendant no. 2. On being contacted and enquiring about availability of the game KLUSTER with him, defendant no. 2 responded in affirmative and also shared the images of the counterfeit product with the plaintiffs. A screenshot of the WhatsApp conversation between the investigator and defendant no. 2 is reproduced as under:-



36. It is submitted that the plaintiffs in view of the aforesaid, issued a Cease and Desist notice dated 15th May, 2024 to defendant no. 2, to which no response has been received till date.

37. It is further submitted that in and around June, 2024, on a routine search, the plaintiffs came across a website www.brainykids.in, whereby



various kids toys and games were being sold. To the plaintiffs' shock, it was found that plaintiff's counterfeit product-KLUSTER is also being sold on this website along with the other games and toys.

38. It is submitted that while tracing the whereabouts of defendant no. 1, the plaintiffs came across another entity- Wow Products LLP. On accessing the master data of the said entity, it was explicitly clear that Wow Products LLP is a partnership concern with Mr. Deval Ravindrabhai Bambhaniya, i.e., defendant no. 1 and Mr. Hardik Kotecha, i.e., defendant no. 2 as partners. Further the LLP was registered on 21st February, 2024 with the address *821 RK World Tower Landmark - Shital Park Brts Company Name Race Course Road, Rajkot*, which was changed later on 30th June, 2024.

39. It is further submitted that it can be inferred that the defendant nos. 1 and 2 are running different entities with the sole intention of selling the counterfeit magnetic game under the mark KLUSTER, in order to ride upon its goodwill and also capture the market share of the plaintiffs. The said defendants are so eager to sell the counterfeit of plaintiffs' product, that despite the plaintiffs serving them multiple legal notices, they temporarily shut sale of counterfeit product from the old entities and keep formulating new entities, just to sell the counterfeit product of the plaintiffs.

40. It is submitted that defendant no. 3 is related to defendant nos. 1 and 2 and are assisting each other to sell the counterfeit product of the plaintiff. It is clear that defendant no. 3 is manufacturing the counterfeit product under the brand 'Brainy kids' for defendant nos. 1 and 2, which is being sold by defendant no. 2, herein.

41. It is further submitted that on further investigation, the plaintiffs came across defendant no. 4 selling a counterfeit product of the plaintiffs either under its own brand name 'MAGMATE- Fun Magnetic Board Game' or



‘KLUSTER’ itself on defendant no. 7, i.e., Amazon. It is believed that defendant no. 4 too might be sourcing the counterfeit products from defendant nos. 1 and 2.

42. It is submitted that around June, 2024, the plaintiffs came across defendant no. 5 selling counterfeit product of the plaintiffs on Amazon, i.e., defendant no. 7. The plaintiffs immediately on 20th June, 2024 issued a cease-and-desist notice to the said defendant. A reply was received on 10th July, 2024, whereby defendant no. 5 furnished an undertaking not to sell the counterfeit product anymore. Further, around end of August, the plaintiffs came across defendant no. 5 still offering the counterfeit products of the plaintiffs, for sale, on defendant no. 7 platform. It is believed that defendant no. 5 might be sourcing the counterfeit product from defendant nos. 1 and 2.

43. It is further submitted that the use of the mark KLUSTER by the defendants, which is identical to the plaintiffs registered mark KLUSTER, in relation to the counterfeit product of the plaintiffs is bound to cause confusion or an association amongst the purchasing public and members of trade as to the origin of defendant’s products.

44. It is submitted that the defendants are manufacturing and selling the counterfeit product, which is an exact imitation of the product of the plaintiffs, thereby the defendants are using the exact mark as that of the plaintiffs. In view of the marks being similar, the consumers are likely to purchase the products of the defendants under a false belief that the same originate from the plaintiffs. Consequently, the defendants’ use of the mark KLUSTER amounts to intentional and willful infringement of the plaintiffs’ statutory rights within the meaning of Section 29 of The Trade Marks Act, 1999.



45. It is further submitted that the plaintiffs through investigation learnt that the defendant nos. 1-5, 10-11 are intentionally selling goods replicating the trademark KLUSTER of the plaintiffs and are selling counterfeit products in order to ride upon the goodwill of the plaintiffs. The defendant nos. 1-5 and 10-11 are manufacturing and selling the products under the mark KLUSTER which is identical and deceptively similar to the plaintiffs' trademark 'KLUSTER' for its products. It is submitted that use of the impugned mark 'KLUSTER' by the defendant nos. 1-5 and 10-11 along with their brand names, for the same products amounts to passing off of the plaintiff's distinctive mark "KLUSTER".

46. It is submitted that the plaintiffs are existing in the market since the year 2019 and are manufacturing and selling a game, for which there is no other trader except plaintiff no. 1 and plaintiff no. 2, who are manufacturing the game and selling the same under the mark KLUSTER. Thus, the defendant nos. 1-5 and 10-11 have imitated the mark of the plaintiffs, and have introduced counterfeit products in the market with identical mark "KLUSTER". The plaintiffs have coined the mark KLUSTER and is prior and only user thereof, since the year 2019, the defendant nos. 1-5 and 10-11 using lookalike mark are bound to be restrained.

47. It is further submitted that the *malafide* of the aforesaid defendants' activities are evident from the fact that they have slavishly copied not only the mark of the plaintiffs without any changes, but also the entire game including the differently shaped magnets and rope together with identical packaging which is bound to deceive the average customer. Thus, it is submitted that from the aforesaid, it is evident that such defendants want to represent themselves as distributors and sellers of the plaintiffs, riding upon the immense goodwill earned by the plaintiffs, over the years.



48. It is submitted that the price at which the plaintiffs' product is sold is around ₹ 1800/-, whereas that of such product of the defendants ranges between ₹ 100/- to 800/-. Thus, these defendants by riding upon the goodwill of the plaintiffs want to divert the consumers towards purchasing their fake counterfeit products.

49. It is further submitted that the defendant nos. 1-5 and 10-11 have intentionally and deliberately adopted identical mark KLUSTER to cause confusion and deception among the traders and consumers. The acts of such defendants amount to counterfeiting and passing off their goods as that of the plaintiffs.

50. It is submitted that defendants' impugned products and plaintiffs' products will be sold through the same trade channels to the same set of customers. The proximity of the identical products being offered for sale on E-commerce websites would also lead to confusion as the consumers will only see the visually identical product packaging and end up purchasing the inferior quality product, believing it to be originating from the plaintiffs. In view of such an act on part of the defendant nos. 1-5 and 10-11, of manufacturing and selling counterfeit products, there exists a strong chance of deception among the consumers regarding the association of the defendants' products with that of the plaintiffs'. Consequently, the members of the trade would, without doubt, be under a mistaken belief that the defendants' products originate from the plaintiffs or that they have some trade connection or affiliation thereby causing irreparable loss and damage not only to the trade and business of the plaintiffs but also resulting in tarnishment of the goodwill of the plaintiffs and its renowned brand.

51. In the above circumstances, the plaintiffs have demonstrated a *prima facie* case for grant of injunction and, in case, no *ex parte ad interim*



injunction is granted, the plaintiffs will suffer an irreparable loss. Further, balance of convenience also lies in favour of the plaintiffs, and against the defendants.

52. Accordingly, till the next date of hearing, it is directed as follows:-

I. Defendant nos. 1-5 and 10-11, their distributors, dealers, stockists, retailers, servants, agents and all others acting for and on their behalf are restrained from manufacturing or authorizing the manufacture, distribution, selling through all modes, exporting, offering for sale online and offline, advertising promoting, displaying and/or using, in any manner, whatsoever, counterfeit products under the mark KLUSTER, and/or any other trade mark identical, deceptively or confusingly similar to the plaintiffs' mark KLUSTER, amounting to infringement of the trade mark of the plaintiffs/amounting to infringement of the copyright of the plaintiffs residing in the label and product packaging/ amounting to passing off of the trade mark of the plaintiffs/ amounting to passing off of the trade dress(s)/product packaging(s) of the plaintiffs/ amounting to passing off of the shape of the goods of the plaintiffs' product sold under the mark KLUSTER;

II. Defendant nos. 1-5 and 10-11 are directed to take down the listing of the counterfeit/unauthorized products, attached as *Annexure-A* to the present order.

III. In case, the requisite action is not taken by defendant nos. 1-5 and 10-11, then, defendant nos. 6-9, are directed to take down all the listings of the counterfeit/unauthorized products being sold under the plaintiffs' trademark KLUSTER, as per *Annexure-A* of the present order.



IV. It is further directed that in case, during the course of pendency of the present proceedings, the plaintiffs discover any new listings of the counterfeit products of the plaintiffs being sold, the same shall be brought to the notice of defendant nos. 6-9, who shall take appropriate action in terms of today's order.

53. Issue notice to the defendants.

54. Notice is accepted by learned counsel appearing for defendant no. 6 and 9.

55. Issue notice to the other defendants by all permissible modes upon filing of the Process Fee, returnable on the next date of hearing.

56. Let reply be filed within a period of four weeks.

57. Rejoinder thereto, if any, be filed within two weeks, thereafter.

58. Compliance of Order XXXIX Rule 3 CPC, be done, within a period of two weeks.

59. List before the Court on 08th April, 2025

I.A. 46075/2024 (Application for appointment of Local Commissioner)

60. The present application has been filed on behalf of the plaintiffs under Order XXXIX Rule 9 CPC read with Order XXXIX Rule 7 and read with Section 151 CPC, seeking appointment of Local Commissioner.

61. It is submitted that in order to preserve evidence of infringement, it is necessary that Local Commissioner be appointed to visit the premises of the defendants.

62. Accordingly, the following directions are issued:

I. Mr. Rohit Ghadia, Advocate (M: 9999333702), is appointed as Local Commissioner, with a direction to visit the following premises of the defendant no. 2:

II. The learned Local Commissioner, along with a representative of the plaintiffs and its counsel, shall be permitted to enter upon the premises of the defendants mentioned hereinabove, or any other location/premises, that may be identified, during the course of commission, in order to conduct the search, and seize the counterfeit and infringing products, materials, including pamphlets, brochures, stickers, etc., containing the infringing trademark 'KLUSTER' and copyright in the product packaging of the plaintiffs.

III. After seizing the infringing material, the same shall be inventoried, sealed, and signed by the learned Local Commissioner, in the presence of the parties, and released on *superdari* to the defendants, on their undertaking to produce the same, as and when further directions are issued, in this regard.

IV. The learned Local Commissioner shall also be permitted to make copies of the books of accounts, including ledgers, cash books, stock registers, invoices, books, etc., in so far as they pertain to the infringing products.

V. Further, the learned Local Commissioner shall be permitted to undertake/arrange for photography/videography of the execution of the commission.



VI. Both the parties shall provide assistance to the learned Local Commissioner, for carrying out the aforesaid directions.

VII. In case, any of the premises are found locked, the learned Local Commissioner shall be permitted to break open the lock(s). To ensure an unhindered and effective execution of this order, the Station House Officer (“SHO”) of the local Police Station, is directed to render all assistance and protection to the Local Commissioner, as and when, sought.

VIII. The fee of the learned Local Commissioner, to be borne out by the plaintiffs, is fixed at ₹ 2,00,000/- (Rupees Two Lakhs). The plaintiffs shall also bear all the expenses for travel/lodging of the Local Commissioner and other miscellaneous out-of-pocket expenses, for the execution of the commission. The fee of the Local Commissioner shall be paid in advance by the plaintiffs.

IX. The Local Commission shall be executed within a period of two weeks from today. The Local Commissioner shall file the report within a period of two weeks from the date, on which the commission is executed.

63. The order passed today, shall not be uploaded for a period of two weeks.

64. In terms of the foregoing, the present application stands disposed of.
