1. Let the plaint be registered as a suit.
2. Issue summons in the suit and notice in the present application.
3. Summons in the suit and notice in the present application are accepted by counsel appearing on behalf of the defendants, who waives formal issuance of summons.



4. Written statement(s) to the plaint and reply(ies) to the application be filed by the defendants within thirty (30) days from today. Along with the written statement(s), the defendants shall also file affidavit(s) of admission/ denial of the documents of the plaintiff, without which the written statement(s) shall not be taken on record.
5. Liberty is given to the plaintiff to file replication(s), if any, within thirty (30) days from the receipt of the written statement(s). Along with the replication(s) filed by the plaintiff, affidavit(s) of admission/ denial of the documents of the defendants be filed by the plaintiff.
6. Rejoinder(s), if any, to the reply(ies) to the present application filed by the defendants, shall be filed on behalf of the plaintiff within two (2) weeks after the receipt of such reply(ies).
7. It is made clear that any unjustified denial of documents may lead to an order of costs against the concerned party.
8. If any of the parties wish to seek inspection of any documents, the same shall be sought and given within the prescribed timelines.
9. List before the Joint Registrar on 14<sup>th</sup> January, 2026 for completion of service and pleadings.
10. List before the Court on 30<sup>th</sup> January, 2026.
