These two applications are still reflecting as pending in the cause list. Learned counsel for the plaintiff seeks some more time to seek appropriate instructions in this regard.

**CS(OS) 115/2018**

The case is fixed for admission/denial and marking of exhibits, but Joint Documents Schedule has not been filed by the plaintiff till date.
